to have been submitted. In consideration of the organisers agreeing to consider the registration of the Exhibitors / Event Partners, the Exhibitors / Event Partners agrees that it shall not at any time during the Relevant Period withdraw its registration. Particulars given shall be stored for automatic data processing and shall be made available to third parties upon implementation of the contract. Registrations shall be processed in the order received.

Any registrations received after the start of space allocation can only be considered if sufficient space is available. Any services offered by companies having exclusive rights in the fairgrounds must be ordered through the organisers.

For the purpose of this clause - Registration – the relevant period shall commence from the date the Exhibitors / Event Partners submits his registration to the organisers and shall end on the last day of the exhibition.

7. Admission

In principle, only those Exhibitors / Event Partners whose product range is covered by the title and remit of the event shall be admitted in the Exhibition. There is no legal right to admission.

The organisers shall have sole and absolute discretion to decide on the admission of exhibitors / event partners and exhibits. Any firm which has failed to meet its financial obligations owing to the organisers or affiliated companies (from previous fair participation and/or under the terms of these Conditions of Participation, or Item 9. may be rejected. Exhibitors / Event Partners will be informed of admission in writing and admission shall apply only to the Exhibitors / Event Partners stated therein. The mailing of the notice of admission gives rise to a contract between the organisers and the Exhibitors / Event Partners.

The organisers shall be entitled to revoke any admission if such admission was based on a misunderstanding, false information or if the preconditions for approval no longer apply. Should the organisers be compelled to relocate or change individual stands, entrances, exits or aisles at a later point in time, this shall not give rise to any claims. If through fault on the part of the organisers the space allocated is no longer available, the Exhibitors / Event Partners shall be entitled to a refund of the participation fee, free of interest, as agreed liquidated damages. No claims for further damages may be submitted.

Following admission by the organisers (conclusion of the contract), the obligation to pay the participation fee shall remain legally binding even if, for example, the authorities in the exhibiting country do not approve, in whole or part, the Exhibitors / Event Partners' s import requirements, or if exhibits for any reason whatsoever fail to arrive in time or to arrive at all (e.g. owing to loss, delays in transit or customs), or if the Exhibitors / Event Partners or his agent is delayed or even unable to attend. Should the

Exhibitors / Event Partners or his agent fail to take over the allocated stand area two days prior to the beginning of the Exhibition, such area may be otherwise disposed of in such manner as the organisers shall determine in its absolute discretion. This shall not release the Exhibitors / Event Partners from his contractual obligations or entitle him to demand for refund or lodge any other claims against the organisers.

8. Terms of Payment

The currency of invoice is in THAI BAHT(THB).

- a. Participation costs set forth in item 6 shall be due upon approval of the registration. The exhibitors / event partners shall be billed for such amounts. 100% of the participation costs must be paid upon confirmation or allocation of space.
- b. Charges for others, separately ordered services or deliveries shall be payable at the time of performance or on the date of receipt of the invoice at the latest.
- c. All remittance are payable to TIChE in the currency inclusive of remittance and beneficiary bank charges and must be made by draft or direct transfer to:

- d. For failure to meet any and all commitments on the part of the Exhibitors / Event Partners, the organisers shall be granted a right of lien in respect of the exhibitor / event partner's stand equipment and exhibits (the "Lien Items") on the understanding that the organisers is entitled to realise and/or sell the Lien Items in order to meet such commitments. The organisers cannot be held liable for damages to/loss of the Lien Items arising from such realisation and/or sale.
- e. If invoices are sent to a third party on the Exhibitor / Event Partner's instructions, the latter shall still remain a debtor of the organisers.
- f. In case of default by the Exhibitor / Event Partner of payment of any sum due to the organisers, interest shall be charged on the outstanding sum at a rate of 7% p.a. Where payment dates are not met, the organisers shall be entitled to rescind the contract or otherwise dispose of the stand area and the Exhibitor / Event Partner shall be responsible for all losses suffered by the organisers. Item 10 of the Conditions of Participation shall apply.

9. Withdrawal or Non-Participation

The Exhibitor / Event Partner shall not be entitled to withdraw his registration or reduce the fair space after submission of the form of registration. Both the participation fee and any other costs actually incurred by the organisers must be paid.

Withdrawal by the Exhibitor / Event Partner or any waiver of the allocated stand area shall only be reviewed upon receipt by the organisers of a written declaration to that effect. The organisers are entitled to rescind the contract in the event of an application for composition or bankruptcy proceedings in respect of the Exhibitor / Event Partner's assets or where such an application is rejected on the grounds of insufficient assets. The Exhibitor shall inform the organisers thereof at once.

10. Exhibits

All exhibits must be listed individually on the Exhibit Listing form giving an exact description. Any display of inflammable or pungent exhibits or exhibits whose demonstration entails noise requires the prior written consent of the organisers.

Exhibits may not be removed during the course of the event. The operation and demonstration of exhibits is only admissible within the scope of accepted standards. The organisers are neither in charge of nor responsible for questions of licenses, quotas or transfers of sales proceeds.

11. Technical Guidelines

The Technical Guidelines are a constituent part of these Conditions of Participation and must be adhered to. The Technical Guidelines shall be handed over to the exhibitor at the latest with the order form for services.

12. Reservations

Any rules and regulations of the host country or the local contractual partner differing from these Conditions or Participation or imposing additional restrictions shall have precedence at all times. The organisers shall not be liable for any resulting losses or other disadvantages to the Exhibitor / Event Partner.

The organisers shall be entitled to postpone, curtail, extend or cancel the event and to close individual or all sections of the fair temporarily or permanently due to Act of God, force majeure, orders/directives imposed by any Government authority or any other unforeseen circumstances. Should it become necessary to postpone, curtail, extend or cancel the event, the Exhibitor / Event Partner's contract shall be transferred to next edition of the event; should he nevertheless waive his right to the stand area allocated to him or insist on withdrawal, a 50% cancellation fee will be applied if made in writing within one month after the organisers has made the announcement of such changes to the event.

The organisers shall be entitled to postpone, curtail, extend or cancel the event and to close the individual or all sections of the event temporarily or permanently due to the reasons from the organisers. The Exhibitor/Event Partner's contract shall be transferred to the next edition of the event; should he nevertheless waive his right to the stand area allocated to him or insist on withdrawal, a 100% full refund will be provided if made in writing within one month after the organisers has made the announcement of such changes to the event.

The organisers shall not be liable for any losses sustained or disadvantages suffered by the Exhibitor / Event Partner as a result of postponement, curtailment, extension or cancellation. Rather, the Exhibitor / Event Partner shall in such case be required to bear a reasonable share of the costs incurred by the organisers in preparing for the event.

13. Copyright

The Exhibitor / Event Partner gives permission to the Organisers to publish before, during and after the Exhibition any and all press releases, photographs, product information, and brochures sent to them for the purpose of obtaining publicity for the Exhibition and/or Exhibitor / Event Partner.

The Exhibitor / Event Partner guarantees that all graphic elements, designs and photos are either:

- 1) original material,
- 2) paid for by the Exhibitor / Event Partner or,
- 3) already in the public domain such that the Organisers cannot be sued for copyright violation.

14. Final Provisions

In submitting the registration, the Exhibitor / Event Partner agrees to be bound by these Conditions of Participation. Any other agreements, individual permits or special arrangements shall require written confirmation by the organisers.

The English text shall be binding. Failing other arrangements subject to the prior consent of the organisers, place of performance for payments is Thailand.

Should any of the above items be or become invalid, this shall not affect the validity of the remaining terms. The resulting gaps shall be filled in such a way as to maintain the sense and purpose of the contract. Any claims of the Exhibitor / Event Partner as against the organisers shall be barred after six months. The period of limitation shall commence with the end of the month in which the event closed.

All costs and expenses (including legal costs on a full indemnity basis) incurred by the organisers in the recovery of any monies payable to it by the Exhibitor / Event Partner or in the enforcement of any terms of these conditions shall be borne by the Exhibitors / Event Partner.

Time shall be of the essence of the contract in relation to all provisions of these conditions as shall relate to the payment of any monies from the Exhibitor / Event Partner to the organisers.

All notices, demands or other communications required or permitted to be given or made under these Conditions shall be in writing and delivered personally or sent by prepaid registered post or by e-mail addressed to the intended recipient thereof at its address specified in these Conditions or in the Application Form (as the case may be), or such other address notified by such party. Any such notice, demand or communication shall be deemed to have been duly served (if delivered personally or given or made by e-mail) immediately or (if given or made by letter) two days after posting and in proving the same it shall be sufficient to show that the envelope containing the same was duly addressed, stamped and posted.

These Conditions and the contract arising there from shall be governed by and construed in accordance with the laws of Thailand. The parties hereto irrevocably submit for all purposes of or connection with any matter or issue relating to these Conditions and the contracts arising therefrom (including disputes relating to the cheques and drafts issued in payment of any sum due to these Conditions) to the non-exclusive jurisdiction of the courts of Thailand.
